

ORDINANCE NO. 54-14

ORDINANCE AMENDING ORDINANCE NO. 55-02 PASSED JUNE 24, 2002 TO REFLECT CHANGES OF DESCRIPTION OF AN AREA IN THE CITY TO PHASE VI, VII, AND VIII, AND ADDITION OF PHASES IX THROUGH XI OF THE SIDEWALK PROGRAM.

WHEREAS, Ordinance No. 13-94 passed February 14, 1994 established Phases II through VIII for the repair and/or replacement of sidewalks and driveway approaches in the City of Reynoldsburg; and

WHEREAS, the descriptions of the areas in Phase IV, VII and VIII have been changed, and Ordinance No. 13-94 was amended by Ordinance No. 55-02 passed June 24, 2002 reflect the correct descriptions of those areas remaining in the Sidewalk Program; and

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF REYNOLDSBURG, OHIO:

SECTION I. That the remaining phases for replacement of sidewalks and driveway approaches of the Sidewalk Program in the City of Reynoldsburg are hereby described as follows:

Phase VI: West side of Rosehill Road North to the North Corporation limit, then West to the West Corporation Limit, then South to the South Corporation limit then East to Rosehill Road.

Phase VII: Northern limit: Livingston Avenue. Eastern limit: Reynoldsburg-Baltimore Road. Southern limit: Corporation Line Western limit: Brice Road.

Phase VIII: Southern limit: E Main Street Eastern limit Taylor Road, Northern/Western limit: residential streets of Kingsley Drive, Mornigstar Court, Sealyham Drive Landseer Drive, Brindle Court.

Phase IX: Northern limit: Corporation Line, Eastern Limit: Taylor Road, Southern limit: residential streets of Priestley Drive, Papillion Avenue, Harrier PL., Mastin PL., Calm Ct., Dickens Drive, Western Limit: Waggoner Road.

Phase X: Northern limit: Palmer Road, Eastern limit Corp. Line, Southern Limit: Corp. Line, Western limit: Reynoldsburg-Baltimore Road.

Phase XI: Residential areas east of Taylor Road to the Corp. lines.

SECTION 2. That the existing description of Phase VI contained in Section 1 of Ordinance No. 13-94 was repealed by Ordinance No. 55-02 passed June 24, 2002. That Ordinance No. 55-02 is hereby repealed and replaced.

SECTION 3. That upon adoption by Council this ordinance shall be in effect thirty days following signature by the Mayor.
